1. Preventive Legal Services

Call your Provider Law Firm for legal consultation and advice on everyday issues as well as important decisions. Letters and phone calls made on your behalf, per subject. Unlimited number of personal legal document reviews (up to 10 pages each)

Standard Will Preparation with yearly updates

Living Will and Health Care Power of Attorney (prepared at same time as your Will)
Trust preparation available at preferred member rate

2. Motor Vehicle Legal Services

Representation for moving traffic violations and certain motor vehicle related criminal charges,
Up to 2.5 hours for driver's license assistance, personal injury/property damage recovery assistance, for claims of \$2,000 or less

3. Trial Defense Services

The Provider Attorney will assist in the defense of civil suits, up to 60 hours in your first year of membership. The hours of attorney time increase with each renewal for 5 years. (Expanded Plan offers 75 hours of benefits for \$25/mo)

4. IRS Audit Legal Services

Up to 50 hours of Provider Law Firm time, including 3.5 hours of pre-trial time for an IRS audit or appearance. Coverage includes the tax return due on April 15th of your first membership year.

5. Preferred Rate on Other Legal Services

Receive 25% off your Provider Law Firm's standard rate for other legal services not covered by your legal plan benefits.

6. Legal Shield Rider (Optional, \$1 per month)

You and your covered family members get round-the-clock toll-free access to a lawyer if you are detained or arrested.

Protect Yourself and Your Family

- 2) never married children, under age 21, living at home
- 3) never married children, under age 23, who are full-time college students,
- 4) never married children, under age 18, living at home, when you act as the legal guardian, and

1. Credit Reports:

You receive an up-to-date Experian credit report at no additional charge. A detailed analysis of your Personal Credit Score will be included with your first credit report.

2. Continuous Credit Monitoring:

Your credit file at Experian will be regularly monitored. Suspicious activity will be brought to your attention, providing you with early detection.

3. Identity Restoration:

Licensed investigators will work to correct damages caused by identity theft. This includes working with affected public agencies, like the Social Security Administration, the US Postal Service and law enforcement personnel. Fraud alerts will be sent on your behalf to all three credit repositories and affected companies and agencies. Proactive searches of applicable local and national databases will be made on your behalf.
